- 3. Those who are already allotted a shop or Open space or Hoardings previously by VMRDA, including their family members (Wife / Husband / Son / Daughter), are prohibited from applying for the bidding.
- 4. If any applicant after being allotted a shop or Open space through this bid, is found to have already been allotted a shop or Open space previously by VMRDA, then the shop or showroom that was allotted previously and the one that is allotted now will get cancelled and VMRDA can initiate criminal action against such fraudulent applications.
- 5. The allotment of shops shall be bid on "As is where is basis".
- 6. The shop shall be utilized for intended purpose only as mentioned in the bid application.
- 7. No bidder shall carryout any unlawful activity in the subject shop premises.
- 8. The bidder shall not store any items which are of combustible nature highly inflammable and dangers material including liquid state.
- 9. The EMD amount of Rs 20,000/- shall be forfeited to VMRDA in case of successful bidder failed to take over the premises/cancel the allotment within the stipulated time.
